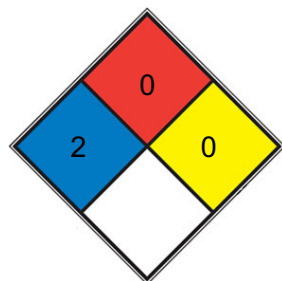

### Waste treatment methods

#### Product

#### Incompatibilities

1,1,1,2-Tetrachloroethane is incompatible with strong oxidizing agents and strong bases. It is also incompatible with dinitrogen tetroxide, 2,4-dinitrophenyl disulfide, potassium, potassium hydroxide, nitrogen tetroxide, sodium and sodium potassium alloy. It may react with chemically active metals, strong caustics, hot iron, aluminum and zinc in presence of steam.

#### Waste Disposal
