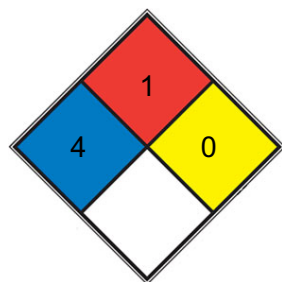

Waste treatment methods

Product
