### If inhaled

SYMPTOMS: Symptoms of exposure to this compound include eye irritation. ACUTE/CHRONIC HAZARDS: This chemical is an eye irritant. When heated to decomposition it emits very toxic fumes of sulfur oxides and nitrogen oxides. (NTP, 1992)



## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures
