## SECTION 4: First aid measures

#### Description of first aid measures

##### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

## SECTION 6: Accidental release measures

**Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### **Persistence and degradability**

In a 4-week biodegradation screening test (MITI test) using dimethoxane (100 ppm) and an activated sludge inoculum, 76-83% of BOD was removed(1).

### **Bioaccumulative potential**

Using an estimated log Kow of 0.49(1, SRC), one would estimate a BCF of 1.4 for dimethoxane using a recommended regression equation(2).

This would indicate that dimethoxane would not bioconcentrate in aquatic organisms(2).

### **Mobility in soil**

The Koc for dimethoxane estimated from molecular structure is 0.56(1). According to a suggested classification scheme(2), this estimated Koc indicates that dimethoxane would be highly mobile in soil.

### Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
