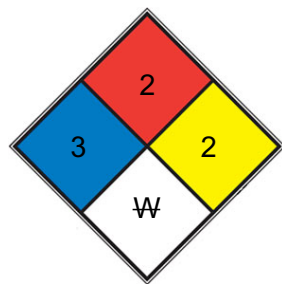

## SECTION 6: Accidental release measures

##### **Body Protection**
