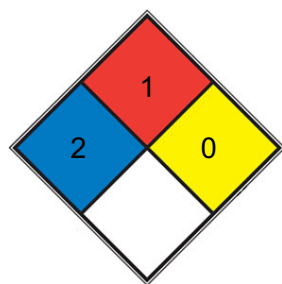

## Waste treatment methods
