This material may be combustible. 4,40-Thiodianiline is incompatible with acids, diazo and azo compounds, halocarbons, isocyanates, aldehydes, alkali metals, nitrides, hydrides, and other strong reducing agents. Also incompatible with peroxides, phenols (acidic), epoxides, anhydrides, and acid halides.

#### Waste Disposal
