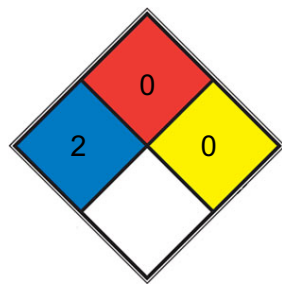

To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

**Toxicity**

A well-known inhibitor of monooxygenase reactions and can also, under some circumstances, stimulate metabolism of xenobiotics in vitro. In either case, the effect is non-competitive, in that the  $K_M$  does not change whereas  $V_{max}$  does, decreasing in the case of inhibition and increasing in the case of stimulation.
