Store in cool place. Keep container tightly closed in a dry and well-ventilated place. Never allow product to get in contact with water during storage.

Handle and store under inert gas. Over time, pressure may increase causing containers to burst. Handle and open container with care. Air sensitive. Moisture sensitive.
