Precautions for safe handling

Avoid formation of dust and aerosols.

Provide appropriate exhaust ventilation at places where dust is formed. Keep away from sources of ignition - No smoking. Take measures to prevent the build up of electrostatic charge.

Store in cool place. Keep container tightly closed in a dry and well-ventilated place. Never allow product to get in contact with water during storage.

Handle and store under inert gas. Over time, pressure may increase causing containers to burst. Handle and open container with care. Air sensitive. Moisture sensitive. Store under argon.

Skin protection

Dispose of contaminated gloves after use in accordance with applicable laws and good laboratory practices. Wash and dry hands.
